



## IGU Conferences in Poland

The IGU Tourism Commission organized two successful meetings in Poland during August 2014. The Pre-Conference, *Tourism and Transition in a Time of Change*, 13-17 August 2014, Kraków / Pieniny Mts, Poland and the IGU Regional Conference, *Changes, Challenges, Responsibility*, 18-22 August 2014, Krakow, Poland, turned out to become great events providing arenas for scientific exchange and debate.

The pre-conference meeting in the Pieniny Mts. In southern Poland gathered some 35 geographers from all continents to discuss various forms of transitions in tourism geographies. Many of the presented papers were not least concerned with economic transitions and analyzed how sudden growth in tourism can be managed. Moreover even the role of tourism as means to counterbalance the negative impacts of economic restructuring was highlighted in several presentations.

A number of papers addressed the issue of transition in the context of recovery of warfare and political turmoil, too, while environmental issues were discussed only by a few.

The conference made clear that various forms of transitions offered challenges but also opportunities for tourism development.

A particular thank you should be directed to the great organizers of the conference, Commission member Assoc. Prof. Marek Więckowski and his colleague Denis Cerić, Polish Academy of Sciences. Besides offering an excellent scientific program, field trips in the Polish Carpathians allowed for gathering impressions of tourism development in the Polish-Slovak borderlands. Without doubt this made the conference a very memorable event.



There are plans to document the outcomes of the conference in a book.

### **Regional Conference Krakow**

Even the Regional Conference in Krakow certainly became an important meeting providing not least an opportunity for geographers from Eastern Europe to interact with the global geography community. The Commission was among the most prominent and active ones during the meeting; it was involved in altogether 22 well attended sessions featuring approximately 80 paper presentations. This underlines the great interest for tourism as a field of geographical inquiry that has been already noted during the Cologne and Kyoto meetings.

Obviously it is difficult to summarize the variety of topics contained in such a massive program. Commission sessions were organized according for the following topics

- Tourism, sustainability and global change
- Tourism and regional development
- Urban tourism geographies
- Geographies of heritage and cultural tourism
- Changing Dynamics of Tourism in Central Europe
- Tourism in mountain areas
- Panel Session: Publishing tourism geographies

Moreover, joint sessions were conducted with the Commission Gender and Geography, the Commission Marginalization, Globalization, and Regional and Local Responses, the Commission on Global Information Society (on Mega events), and the Commissions for Political Geography (on Borders and Tourism, dark heritage and war, respectively).

An outcome of the conference is certainly related to the encounter of Eastern European tourism geographies, which obviously developed relatively isolated, and not least English speaking geographies since many new contacts could be established.

Particularly the panel session on “Publishing tourism geographies” turned out to be a great success attracting about 40 delegates. This session was organized as reaction on interest voiced by young scholars during previous meetings and aimed at encouraging international publishing ambitions. Not least attendees from Eastern European countries were appreciative regarding this initiative, which will be repeated during the IGU meeting in Moscow.
